FELTON

FELTON (CONT'D)
(toward Malus)
Is everything okay?

WEBBER
We're fine.

FELTON
(very concerned, to Webber)
Are you going to be alright here?

WEBBER
Alright?

FELTON
Safe?

WEBBER
Yeah, I'll be good.

FELTON
I don't feel comfortable leaving you here.

WEBBER
(forcing a smile)
He's just disappointed with me.

FELTON
Maybe we should let this situation cool down, and come back another day.

WEBBER
Naw. No. Don't worry about me.

Felton nods and begins to gather his belonging to leave.

FELTON

WEBBER
Sir, I'll be fine.

Felton reaches into his bag.

FELTON

I forgot to give you your prescription.

Felton hands Webber a bag with his prescription meds enclosed.

HART

What the fuck is that for?

FELTON

FELTON

HART
